

ACHEMA 2027, 14 – 18 June 2027, Frankfurt/Main, Germany

General Booking Information

The Reference Point is the officially appointed UK and Ireland representative for [ACHEMA](#), the world forum for the process industries, to be held in Frankfurt/Main from 14 – 18 June 2027.

ACHEMA is the most eminent trade show and conference for this whole sector, the international platform to showcase products and technology in 12 exhibition groups. The exhibition grounds in Frankfurt offer an impressive 233.000 sqm, spread over [8 multistorey halls](#), and an additional outdoor area.

To assist you with booking this event, we have put together a brief outline of the general registration process. We hope you find this information useful; please contact us with any further queries you may have.

Exhibiting at ACHEMA 2027

Please take note of the comprehensive [application documentation](#) that you will have to acknowledge to have read when you book online. It will alert you to booking and payment deadlines and forms part of your legally binding contract with ACHEMA.

Please also note that completing the online form is NOT a submission for information request, it is a legally binding booking of exhibition space.

When you apply for exhibition space at ACHEMA 2027 your request only turns into a proper booking to be considered and stand suggestion supplied when you pay the first installment of Euro 94.00/sq m of the overall stand fee. The invoice will be issued within 14 days and requires immediate payment. For general payment information please see page 2.

Booking stand space:

For previous exhibitors: Should your address and personal contact details have changed then please [contact us](#) as soon as possible and provide your direct contact for ACHEMA in your organisation. We will require the contact details of an individual as any health & safety information in the future will be sent to a dedicated person.

For new exhibitors: We have made booking for ACHEMA 2027 easy. You have the option of booking online where you also find our very [comprehensive booking application information](#) (scroll down to links) that does not only include contractual information but also hall overviews and booking forms. Stand bookings can be made [online](#) or by pdf if otherwise not possible. [Please contact us](#) in such a circumstance. Please [contact us](#) with any comments or questions that you might have either in advance or while submitting your booking form.

Floor space requirements:

The minimum floor space requirement to exhibit at ACHEMA is 12 sqm with a price starting at €378/sqm for space only. This does not include services or stand construction. There are surcharges for specific types of stands and hall locations (ref. point 8 of the official booking information).

We will try to do our best to match your requirements specified on your application form but cannot always guarantee to be successful. Exhibitors have up to five days to confirm from receipt of their offer of stand space.

Admission as an exhibitor:

You will be admitted as an exhibitor once you have confirmed the final stand offer. Our ACHEMA team in Frankfurt will email your admission letter that includes a user ID and password. These allow you to access the [Exhibitor Portal](#).

You will be able to book several **stand construction** options, ranging from all-inclusive packages to individual stands in this portal. **Services** that you need for your participation such as electricity, hospitality, catering, compressed air, furniture, AV, compressed air, additional **exhibitor tickets and submitting your catalogue details** must be facilitated by yourselves via this portal.

Exhibitor passes:

Exhibitor passes proportionate to stand size:

3 passes for 12 m² – 20 m²; 1 additional pass for each further commenced 10 m² up to a maximum of 51 exhibitor passes, as well as set-up and dis-mantling tickets.

Payment schedule for floor space:

Approval of the exhibitor's application for an exhibition space by DECHEMA requires the payment of the first instalment of the stand rent. The contract between DECHEMA and the exhibitor becomes legally binding when the first instalment has been invoiced.

The term of payment for the first installment is within 14 days after receipt of invoice, which will be dispatched electronically by PDF.

EUR 94.00/per booked sq m will be charged as the first instalment upon application (EUR 38.00 for outdoor space and EUR 61.00 for space requested at a special rate).

65% of the balance is due on 15 September 2026 (when the visitor flat rate will be invoiced) and the remaining 35% is due on 15 February 2027, when the mandatory media package fee will also be charged (EUR 495.00 for both exhibitors and co-exhibitors).

Co-Exhibitors:

Co-exhibitors wishing to share a main exhibitor's stand are welcome at ACHEMA 2027.

The admission fee is Euro 1,060 with €495.00 for the mandatory media package.

Main exhibitors must register the co-exhibitor online.

Cancelling your exhibition space:

A cancellation up to 31 January 2026 is free of charge.

From 1.2.2026 – 31.8.2026 the first installment of your participation fee (Euro 94.00/sq m) will be charged as compensation.

From 1.9.2026 – 14.3.2027 50% of the participation fee will be charged.

From 15.3.2027 onwards 100% of the agreed fees will come due.
